Please pack a lunch for your student for the day. WE ARE NUT FREE. Just a reminder school policy is only MES students and 1 adult per child can attend.

We will leave at approximately 12:00 pm to return to MES. Bus should return to MES about 1:00 PM. Please be sure to pick up your students at the south doors by 1:00PM.

The bus is only for the use of current students, adult chaperones, teachers and staff. **We are limited on the amount of chaperones we can take on the bus.** If you are interested in attending the field trip and being a chaperone, please indicate this on the next page. *Any parents who would like to drive and meet us there are welcome to attend.* If you are planning on driving please on the following sheet as need to give total count to the place.

ACKNOWLEDGEMENT AND ASSUMPTION OF RISKS, WAIVER AND RELEASE OF LIABILITY, MEDICAL CONSENT AND INDEMNITY AGREEMENT

In exchange for participation in the activity of indoor play organized by Ball Factory, LLC, I agree for myself and (if applicable) for the members of my family, to the following conditions:

1. I represent that I am the parent or legal guardian of the participant(s) named below, or I have obtained permission from the parent/legal guardian of the participant(s) named below to execute this agreement on their behalf. I further represent that the participants are healthy and physically able to participate in any and all undertaken activities.
2. I agree that the participant(s) named below and I shall comply with all stated and customary terms, posted safety signs, rules, and verbal instructions as conditions for play and participation in any party and/or program at Ball Factory, LLC. I agree to pay for all damages to the facilities of Ball Factory, LLC caused by my or my family's negligent, reckless, or willful actions. In addition, if I observe any hazard during our participation, I will bring it to the attention of the nearest Ball Factory, LLC employee or official immediately.
3. I hereby expressly authorize Ball Factory, LLC to use this waiver as multi-use-waiver until such time as I revoke it in writing with notice to Ball Factory, LLC.
4. I acknowledge that there are known and unknown risks associated with the Child's participation in the Activities, including slips and falls; impact with toys or equipment on the Premises or with other children; the negligence or carelessness of others including failure to follow the Rules; and negligence on the part of the Rules including failure to take reasonable steps to safeguard the Child from the risks of participating in the Activities and failure to take reasonable steps to operate or maintain the Premises. I accept and fully assume, without limitation, all such risks associated with the Child's participation in the Activities and the possibility of personal injury, death, property damage or loss resulting there from.
5. I acknowledge that Ball Factory, LLC. is not responsible for the provision of child care services for the Child.

Accordingly, I agree that I will remain on the Premises at all times during the Child's participation in the Activities, and I assume sole responsibility for supervision of the Child and for understanding and following Ball factory's rules associated with the Child's safe participation in the Activities.

6. I understand that the Ball Factory may refuse the Child's participation in the Activities for any reason, including, but without limiting the generality of the foregoing:
 - a. failure by me or the Child to follow Ball Factory's rules, in the sole discretion of Ball Factory;
 - b. my failure to remain on the Premises during the Child's participation in the Activities;
 - c. my failure to adequately supervise the Child or to ensure that the Child is adequately prepared for safe participation in the Activities, in the sole discretion of Ball Factory; and
 - d. the Child's suffering from an illness or ailment of any kind that may impair his or her continued participation in the Activities or that may be contagious or potentially harmful to others on the Premises, in the sole discretion of BF
7. I acknowledge that any and all personal property left on the Premises is left at my own risk, and that the Ball Factory is not liable for lost, damaged or forgotten items.
8. I hereby irrevocably waive, release and fully discharge Ball Factory from and against any and all liability for loss, damage, personal injury, including death and disability, and costs of any kind and nature whatsoever which I or the Child may suffer now or in the future by reason of or existing out of any causes whatsoever related to or arising out of or from the participation of the Child in the Activities or presence of the Child on the Premises, including negligence, breach of contract, and breach of any statutory duty or other duty of care on the part of the Ball Factory. I accept that this release covers and includes, but is not limited to, all unknown and unforeseen claims, injuries, damages and losses, and

any consequences thereof, including aggravation of injuries caused by negligent rescue operations or procedures.

9. The undersigned on his or her behalf and on behalf of any executors, heirs, successors and assigns, hereby releases, discharges, and holds harmless any authorized entity doing business as Ball Factory, including its officers, agents, employees, representatives, and all affiliates, from any and all claims, damages, or liability arising from death, disability, personal injury, property damage, or theft, or any kind of action
10. I do approve use of photographs or films taken by Ball Factory in which I or the Minor is part of and for the use thereof by Ball Factory, LLC in its marketing and promotional materials.
11. I acknowledge that this agreement, along with the rules of Ball Factory as posted on the Premises, creates and constitutes my continuing obligations respecting the Child's participation in the Activities at any time.
12. Each provision of this agreement is severable. The invalidity or unenforceability of any provisions of this Agreement shall not affect the validity or enforceability of any other provision of this Agreement, which shall remain in full force and effect

I HAVE READ THIS AGREEMENT THOROUGHLY. I UNDERSTAND THAT, BY SIGNING THIS AGREEMENT, I AM WAIVING CERTAIN LEGAL RIGHTS WHICH I, MY CHILD, AND OUR HEIRS, ASSIGNS, EXECUTORS, ADMINISTRATORS, PERSONAL REPRESENTATIVES, AND NEXT OF KIN MAY HAVE AGAINST THE RELEASEES, INCLUDING THE RIGHT TO SUE. I HAVE BEEN AFFORDED THE OPPORTUNITY TO REFUSE THE CHILD'S PARTICIPATION IN THE ACTIVITIES BUT I HAVE FREELY AND VOLUNTARILY ELECTED TO SIGN THIS AGREEMENT.

I UNDERSTAND THAT THE RELEASEES ARE RELYING ON THIS FULL RELEASE AND WAIVER OF ALL CLAIMS WHEN ACCEPTING THE CHILD'S PARTICIPATION IN THE ACTIVITIES.
