Preschool will have their February field trip on Wednesday, February 21st, 2018. We will leave promptly at 9:45 am from MES, therefore please be at the school by 9:30 am. Our check in time is 10:00 am. During our time at Pump It Up, the children will be able to explore the different inflatables and challenge their motor skills. Students will be jumping for an hour and half. **Students should wear comfortable clothing and socks.** Just a reminder school policy is only MES students and 1 adult per child can attend.

We will leave at approximately 11:40am to return to MES. Bus should return to MES about 11:50 AM. Please be sure to pick up your students at the south doors by 11:50 AM.

The bus is only for the use of current students, adult chaperones, teachers and staff. **We are limited for the amount of chaperones we can take on the bus. The chaperones will be picked on a 1st come 1st serve basis.** If you are interested in attending the field trip and being a chaperone please indicate this on the next page. *Any parents who would like to drive and meet us there are welcome to attend.* If you are planning on driving please let me know beforehand. We need to give total count to the place.

**** Please remember ALL ES/EC students must be in a seatbelt if riding the bus. Due to this we have limited space on the bus. ****

The cost for each child is \$7.00! Each adult chaperone cost is FREE! If you are planning on driving and meeting us there you will have to walk in with the class. Please indicate on the following sheet.
